Starting Monday, May 2, 2022, honor your hometown heroes who have served or are serving by purchasing a full color, double-sided, 24 x 48 banner for \$100.00. The banner will include your heroes' photo, name, and branch of service. They will hang on the street light posts throughout downtown Tipton for one year beginning in July. Please note that they will be removed during the harsh winter months to help preserve them (January – mid March). They will be provided to the purchaser once permanently removed from the street light posts at the end of June 2023.

We are very grateful for everyone that has served or is currently serving our country. The Hometown Hero project is an excellent way to honor our veterans in a very personal way.
